PROPOSED ORDER

The Court has reviewed Class Counsel’s Motion for Orders authorizing final distributions to class members of the net amount remaining in the settlement fund established for the benefit of Settlement Class Members pursuant to the Settlement Order and Final Judgment herein and payment of the class administrator’s fees and disbursements, and the supporting Declarations of Peter R.
